- B. <u>Prioritized</u>
 - 1. Accessible pedestrian signals (Nut Tree Rd/Bel Air Ave, Nut Tree Rd/Nut Tree Pkwy, Allison Dr/Ulatis Dr) \$30,000
 - i. Quote for equipment and installation at all three locations: \$25,550.88
 - ii. A contingency of \$4,449.12 is recommended.
 - 2. Rocky Hill Pedestrian Project, Phase 1 \$55,000
 - i. Lister Construction agreed to include ramp on E. Monte Vista @ Brown Street for a total project price of \$46,200.
 - ii. A contingency of \$8,800 is recommended.
- C. <u>Projects Under Consideration</u>
 - 1. Sidewalk/driveway along the south side of Alamo Drive east of Marna Drive
 - i. Will start looking at this after completion of the above two.
- D. Current Requests not Prioritized
 - 1. Highland Street Ramp Project \$87,000
 - i. Due to limited funds, project will not be prioritized. The Rocky Hill Pedestrian Project was proposed as an alternative.

The total amount available as of December 12, 2018 is \$110,763.54. Of this amount, \$55,000 has been encumbered for the Rocky Hill Pedestrian Project – Phase 1. An additional \$30,000 has been encumbered for the Pedestrian Signal Project. Finally, a reserve of \$20,000 is earmarked for emergency and/or critical projects, leaving \$5,763.54 available for projects.
