- October 9, 2015 through June 27, 2017 State legislation and state voters adopted a series of laws effectively legalizing all cannabis in California.
- The new consolidated provisions are now known as the Medicinal and Adult Use Cannabis Regulation and Safety Act (MAUCRSA).
- State licensing regulations became effective January 1, 2018.
- On January 26, 2016 Vacaville City Council adopted the Medical Cannabis Regulations ordinance that permanently prohibited all medical cannabis businesses and operations.
- The ordinance included a sunset clause relating to the personal cultivation of medical marijuana by qualified patients and primary caregivers which expired February 26, 2018.



- September 26, 2017 Vacaville City Council extended the interim ordinance to prohibit both medical and recreational marijuana.
- This ordinance expires September 26, 2019.
- City Council directed Staff to analyze the effects of industrial, retail, and commercial cannabis land uses, and outdoor cannabis cultivation.
- December 11, 2018 Vacaville City Council established regulations on personal cannabis cultivation (follows State standards).
- "Open House" for recreational cannabis activities held on April 17, 2019.

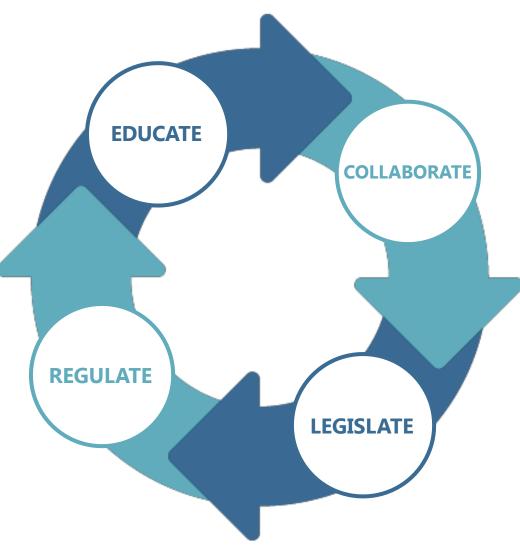

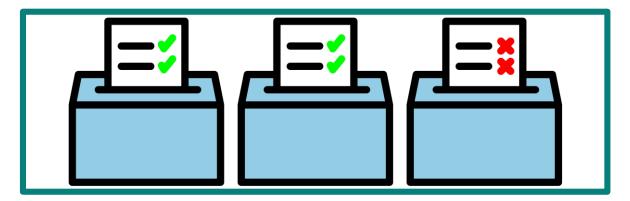

CALIFORNIA CANNABIS LAWS

PROTECTS LOCAL CONTROL BY:

- **Dual licensing:** A requirement in statute that all marijuana businesses must have both a state license and a local license or permit to operate legally in California. Jurisdictions that regulate or ban medical marijuana will be able to retain their regulations or ban.
- **Enforcement:** Local governments may enforce state law and local ordinances if they request that authority and if it is granted by the relevant state agency.

MEDICINAL & ADULT-USE CANNABIS REGULATION AND SAFETY ACT (MAUCRSA)



License Types

State Cannabis Licensing Authorities



Bureau of Cannabis Control

Housed within the California Department of Consumer Affairs, the Bureau will license *retailers, distributors, third-party testing laboratories* and *microbusinesses*.



Manufactured Cannabis Safety Branch

Housed within the California Department of Public Health, MCSB will license **manufacturers** of cannabis products. This includes nearly all non-flower products (edibles, oils, tinctures, etc.).



CalCannabis Cultivation Licensing

Housed within the California Department of Food & Agriculture, CalCannabis will license *cultivators* and implement the state's *Track-and-Trace* system to record movement of cannabis from seed to sale.

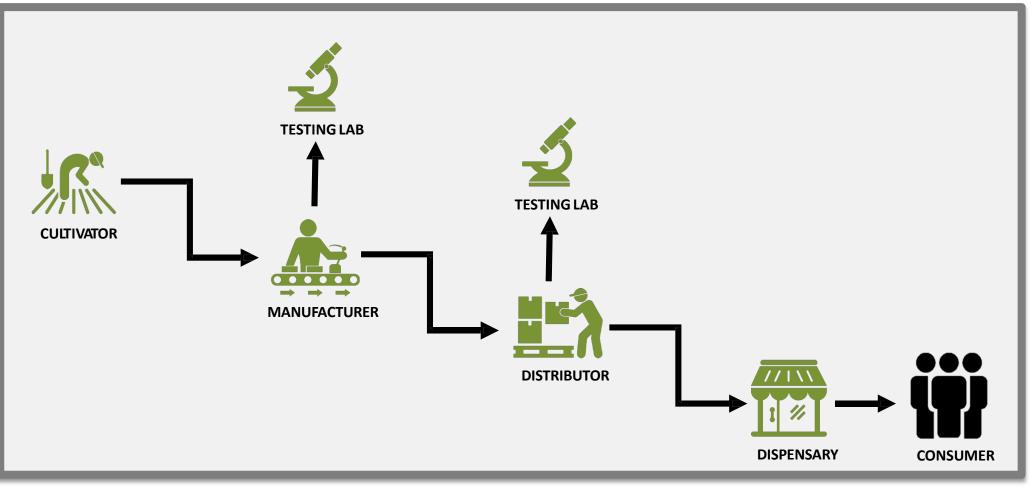

ADULT USE (RECREATIONAL) OR MEDICINAL

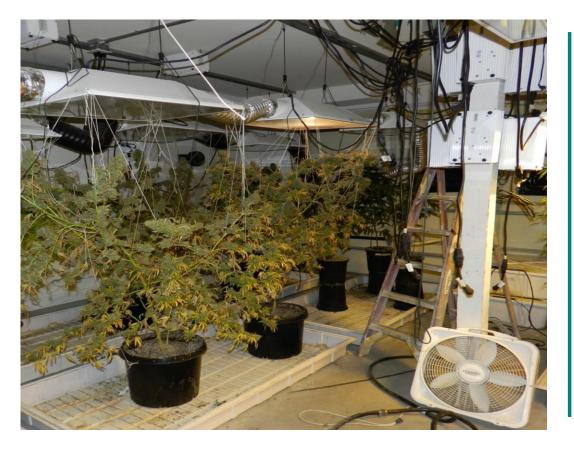
- 1) <u>CULTIVATORS</u>: Numerous license types for commercial cultivators, ranging from specialty cottage to medium-sized grows
- 2) **NURSERIES:** Cultivation of cannabis solely as a nursery, including cloning and seed propagation
- **3) PROCESSORS:** A site that conducts only trimming, drying, curing, grading, or packaging of cannabis and nonmanufactured cannabis products

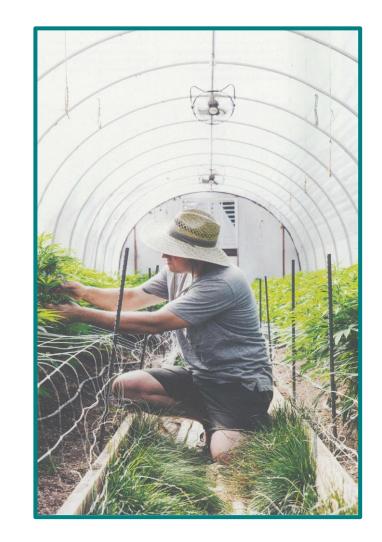






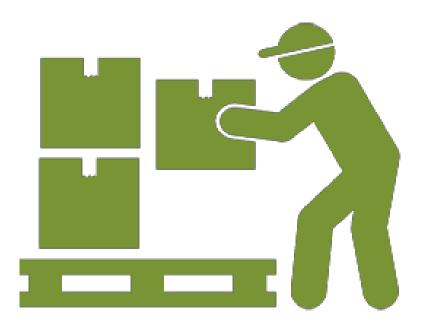
E IMPACTS OF HEMP IN THE COMMUNITY

- ✓ Farm Bill Act of 2018 removed hemp from Controlled Substance Schedule
- Local communities have not developed ordinances to ban it yet
- Creates alternatives to cannabis but may also change strategies of the cannabis industry
- Hemp Oils will be in mainstream stores such as Walgreen, CVS and GNC in California in the future
- Will create odor nuisances just like cultivation









DISTRIBUTOR TRANSPORT ONLY

- A licensed distributor transport only licensee may transport cannabis goods between licensees
- Shall not transport any cannabis goods except for immature cannabis plants and seeds to a licensed retailer or licensed microbusiness authorized to engage in retail sales

KEY REQUIREMENTS

- Transport vehicles must have an active alarm system
- Must generate a shipping manifest

LICENSE TYPES

- Type 6 Non-Volatile Solvents
 - Carbon dioxide, ethanol, water
- Type 7 Volatile Solvents
 - Butane, hexane, pentane propane
- Type N Infusions
 - No extraction, infusion only
- Type P Packaging and labeling

REQUIREMENTS

- A-licenses and M-Licenses may have the same premises
- All cannabis goods must be placed in an opaque exit package prior to leaving the premises
- Deliveries may be made only by employees of the retailer
- Deliveries must be to a physical address
- The retailer must be able to immediately locate all delivery vehicles

REQUIREMENTS

- A microbusiness licensee must conduct at least 3 of the 4 following commercial activities
- Must indicate on the application for licensure which commercial cannabis activities the applicant intends to engage in
- Must comply with all requirements for each activity



TESTING LABORATORIES



REQUIREMENTS

- Owners of a Testing Laboratory are prohibited from conducting other commercial cannabis activities
- A licensed Laboratory shall maintain ISO accreditation
- Testing requirements will be phased in
- Laboratories will be required to produce a certificate of analysis containing pass/fail results

CANNABIS EVENTS



IMITATIONS

- The organizer of the event must first obtain a cannabis event organizer license
- Sales of cannabis goods must be performed by a retailer or microbusiness approved to engage in retail
- Access to the area is restricted to persons 21 years of age or older
- Onsite consumption must be done in accordance with the local jurisdiction's requirements
- Security must be present at the event

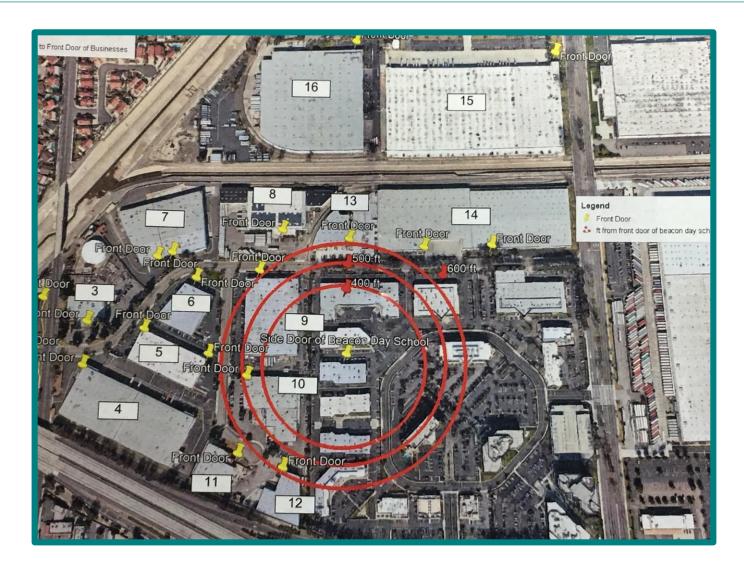

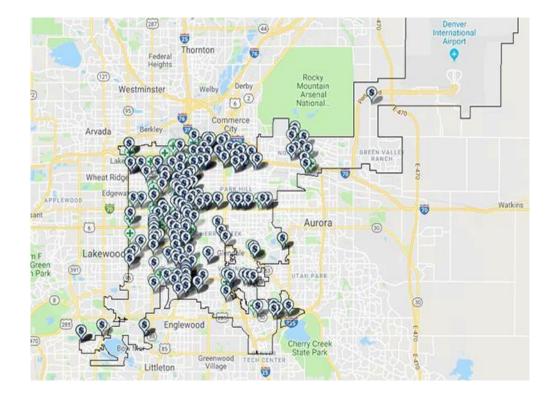


LAND USE BUFFER OPTIONS









STRATEGIES TO ADDRESS INCREASED YOUTH ACCESS

Density: Studies show that concentration of alcohol retailers can increase abuse of alcohol by youth. Cities can control the density of cannabis retailers by requiring them to be located a minimum specified distance from one another.

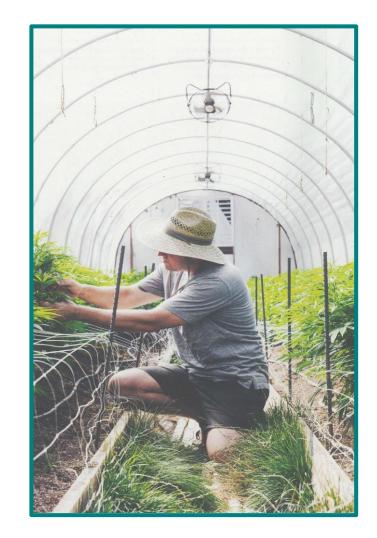

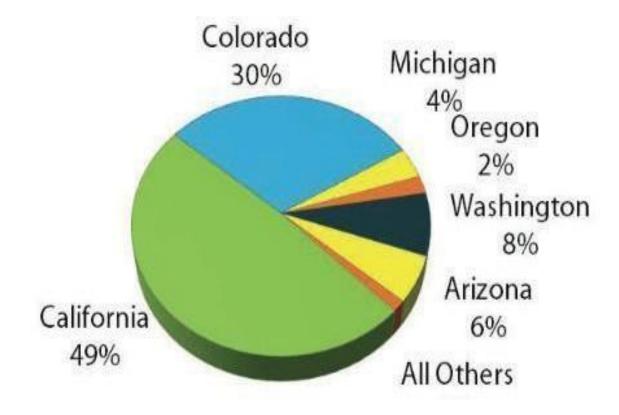

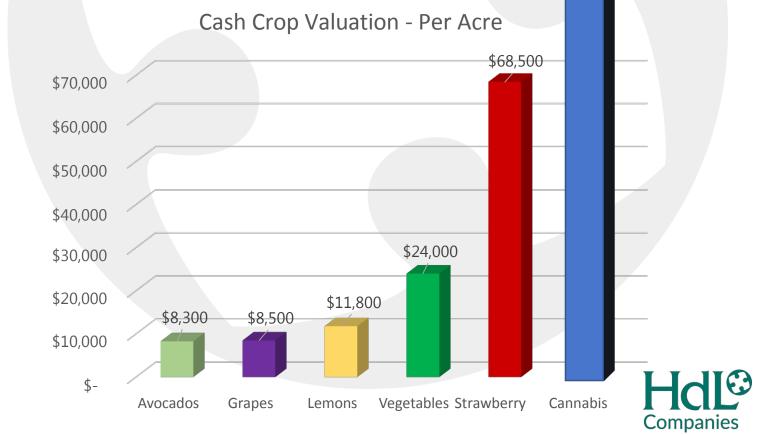


CALIFORNIA'S MARKET SHARE





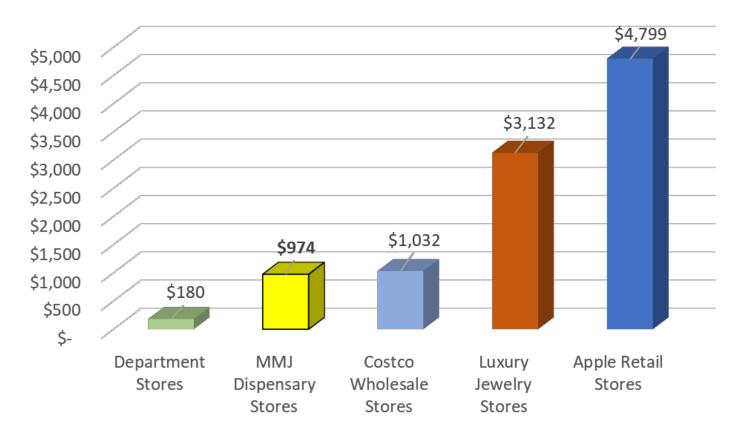
CASH CROPS VALUATION

AVG. ANNUAL REVENUE PER SQ. FT.

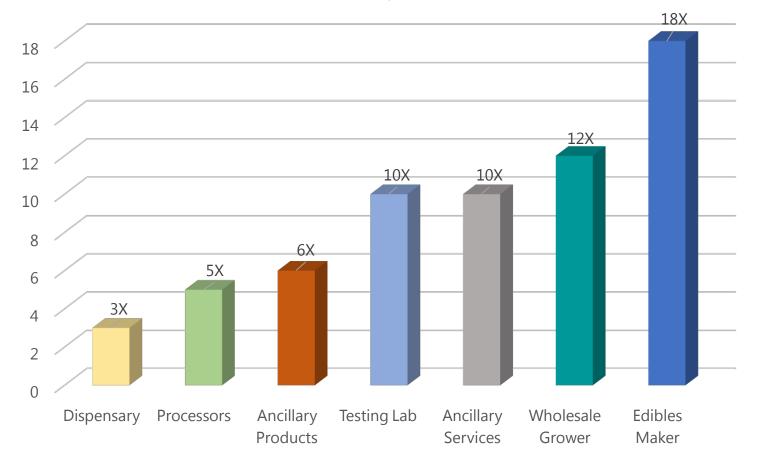
Avg. Revenue Per Sq. Ft.





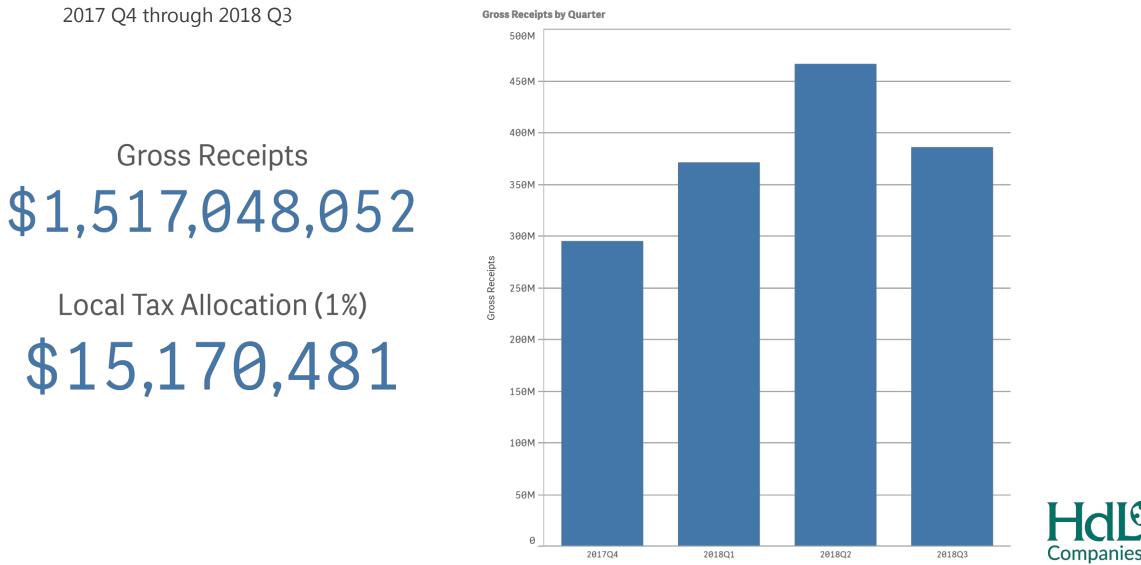


Profitability in 2020

There are 35 cannabis businesses listed on the stock exchange.

- Creates first mover advantage over other businesses which are not on the Canadian or U.S. stock exchanges
- Businesses can leverage millions of dollars in funding to scale their business operations and brands
- They can acquire other businesses that help develop their business model
- They can build infrastructure to become vertically integrated throughout the state and country
- They can sustain longer term stabilization which other businesses may not be able to achieve

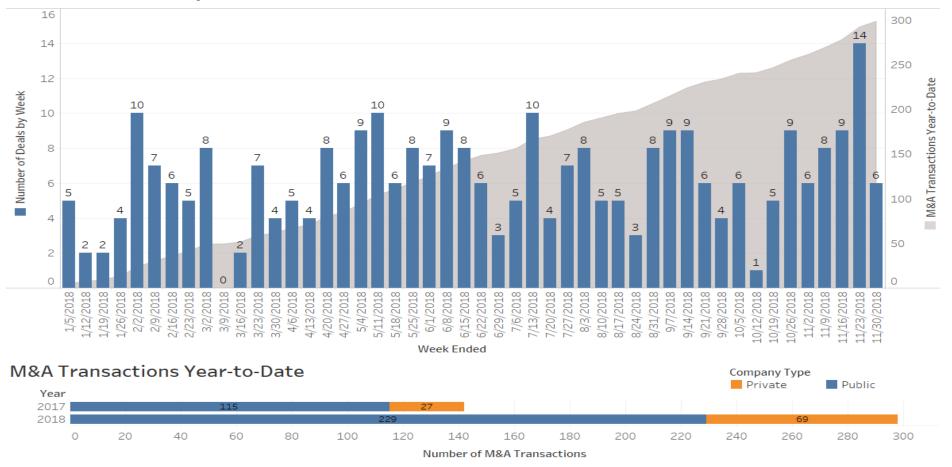

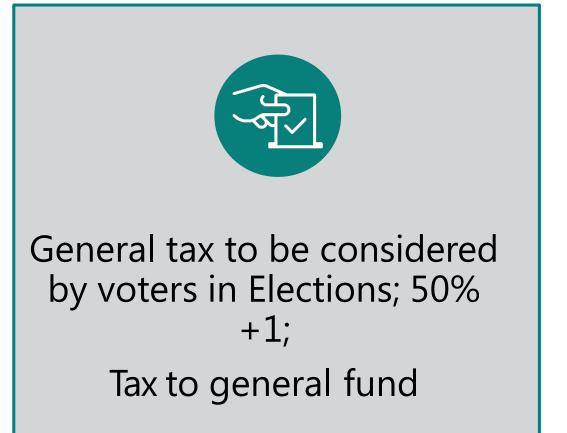




HOW DO CITIES GENERATE REVENUE



Standard fees to recover City costs







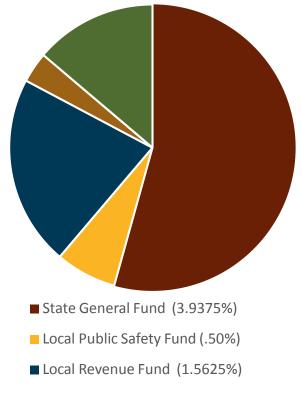

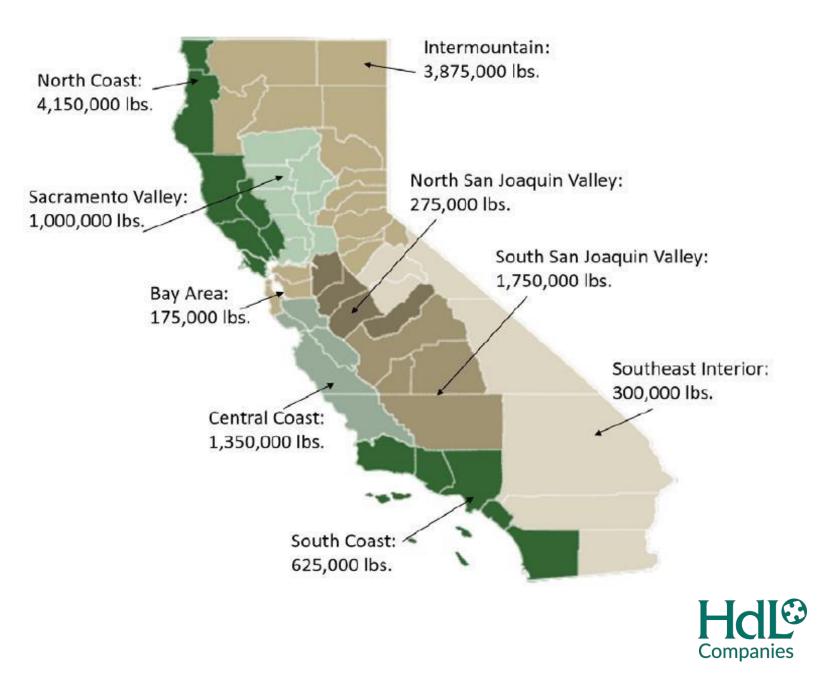

REGIONAL CANNABIS PRODUCTION

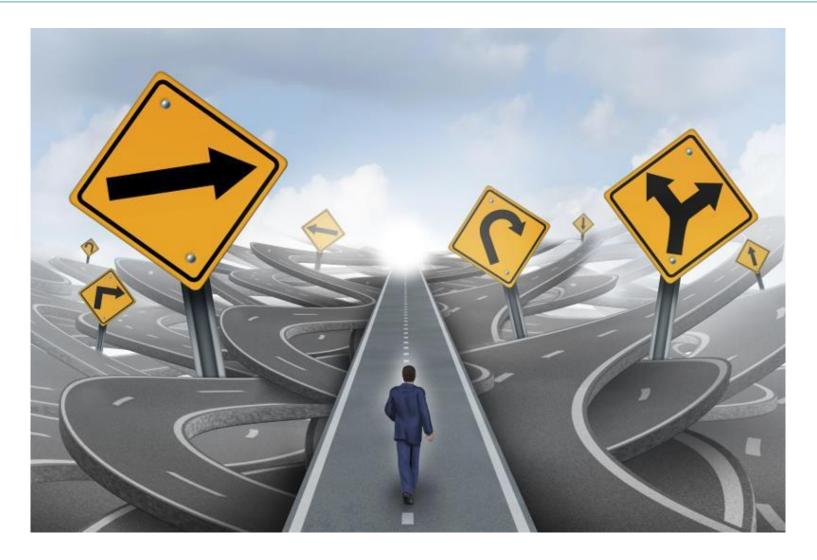




- Cannabis cultivation in California exceeds the size of the legal market by 5 to 8 times
- ✓ Interest in legal cultivation licenses exceeds the size of the legal market by 12 to 16 times
- California's entire market could potentially be supplied by as few as 200 Type 3A Medium Indoor grows

 - Enforcement of regulations.
 - Potential negative image issues for the City.
 - Possible economic benefits.
- Prepare an ordinance to ban all recreational and medical cannabis business types until all issues are addressed properly.
