ELEMENT 2. ORGANIZATION

This SSMP element describes the organization of the Utilities Department and Public Works Department responsible for the management, operation, and maintenance of the City's wastewater collection (sanitary sewer) system. It identifies City staff responsible for implementing the WDR compliance program. Also, the Legally Responsible Officials in the chain of communication for reporting sanitary sewer overflows (SSOs) are identified. The major items discussed in this element are as follows:

REGULATORY REQUIREMENTS

The requirements for the Organization element of the WDRs are listed in Table 2-1. The requirements are listed by WDR paragraph number and by Section 2 heading under which the requirement is addressed.

CITY COUNCIL AND DEPARTMENTAL OVERVIEW

The City's overall organization is headed by the City Council and the City Manager. The City Attorney's Office and the Chief Building Official provide legal, enforcement, and building & plumbing code support related to sanitary sewer systems and Fats, Oil, and Grease (FOG).




Figure 2-1. Organization Chart of Sanitary Sewer Staff

Figure 2-1 depicts an overview of the City's field staff and management that have responsibilities as First Responders and Legal Responsible Officials (LRO). The First Responders also includes Public Works Supervisors as LRO's and certain staff designated as Data Submitters. An SSMP Implementation Chart and Narrative is attached as Exhibit 2A for a detailed depiction.

The Utilities Department is responsible for the management, operation, and maintenance of lift stations and the Easterly Wastewater Treatment Plant. The Utilities Department is also responsible for implementing and enforcing the City's NPDES and SSMP permits.

The Public Works Department Engineering Services Division oversees the design and construction of collection mains, trunk sewers, lift stations, and force mains, and maintains collection system asbuilt drawings and system mapping.

The Public Works Department Maintenance Division is responsible for the management, operation, and maintenance of force mains, collection mains (sanitary sewers less than 12 inches in diameter) and for the maintenance of trunk sewers (sanitary sewers 12 inches and greater in diameter).

The list of current City Council and Department Directors is attached as Exhibit 2B. Each department updates its organizational chart periodically, as needed.

Authorized Representatives and current Legally Responsible Officials

The City's duly authorized representatives, also referred to as Legally Responsible Officials (LROs), as defined in Section J of the WDR, are listed in Table 2-2. The Engineering Specialist has been designated as the SSMP Program Manager for the Utilities Department since December 2013. For day-to-day activities, the SSMP Program Manager is responsible for overall permit management, audits, LROs & DS lists, and regulatory agency communication.






