## I. INTRODUCTIONS AND ROLL CALL

## II. APPROVAL OF MINUTES

#### III. NEW ITEMS

- S. Brown addressed the backup of items to approve due to insufficient membership. Proposed to reduce the number of members or reduce the quorum requirements. Three approaches were discussed:
- 1. Permanently reducing the size of the Committee from 7 members to 5 members thereby reducing the quorum from 5 to 3; or
- 2. Building in a trigger clause to temporarily reduce the quorum following an extended period of reduced membership; or
- 3. Allowing for a reduced quorum if membership falls below a certain threshold at any time.

The preferred approach was to permanently reduce the size of the Committee from 7 members to 5 members and reduce the quorum to 3 Committee members. D. Medina, E. Tonic – Unanimously approved.

- A. Signs on Vine Street @ E. Monte Vista
  - Resident contacted ADA Office to inquire about signs on Vine Street that impede the sidewalk. City investigation found that the signs meet ADA standards (Attachment 1)

Project is not prioritized. The signs do not violate ADA standards.

Discussion of various outreach efforts included Vacaville Magazine, church groups, pins, tear away signs, and flyers in physical therapy offices.

Brown contacted the Committee via email requesting approval to move forward with a bulk pricing offer to complete both projects at a total of \$71,400. Quote included expanding Phase II of the Rocky Hill Pedestrian Improvements Project to include all 10 remaining curbs. Projects were unanimously approved by all members.
