III. NEW ITEMS

A. Curb Ramp Request: Gregory Drive at Gregory Court (Attachment 1)

Committee reviewed the request at Gregory Court noting that due to the location, the two requested ramps would likely serve a very small group of residents. Alternate access points (adjacent driveways) were identified and the location was not considered a high traffic or low visibility area. D. Medina moved to not prioritize this project for the reasons above. D. Troxil second. Unanimous.

B. Curb Ramp Request: Leisure Town (Attachments 2A & 2B)

a. Grand Canyon @ Sequoia

b. Grand Canyon @ El Dorado

c. Grand Canyon @ Monterey

Committee reviewed request for curb ramps at three intersections in Leisure Town and discussed primary factors: cost, benefit, existing accessibility, safety. The location of the project would result in limited impact – serving a small group of residents in the immediate area only, and none of the sites connect residents to necessary amenities. Alternative points of access were noted (adjacent driveways). The location is not in a high traffic or low visibility area. D. Troxil moved to not prioritize this project for the reasons above. E. Tonic second. Unanimous.

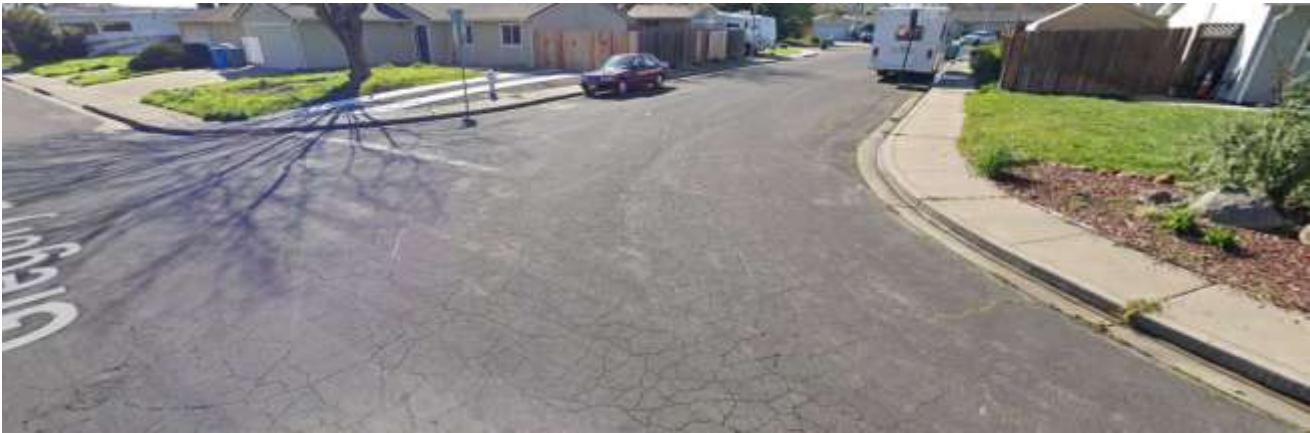
