

RESOLUTION NO. 2018-022

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF VACAVILLE AUTHORIZING THE CITY MANAGER TO EXECUTE THE FUNDING AGREEMENT BETWEEN THE SOLANO TRANSPORTATION AUTHORITY (STA) AND THE CITY OF VACAVILLE FOR THE DESIGN AND CONSTRUCTION OF JEPSON PARKWAY, INCLUDING FROM ELMIRA ROAD TO APPROXIMATELY 450 FEET SOUTH OF ORANGE DRIVE – PHASE 1B & 1C

WHEREAS, the Solano Transportation Authority (STA) is responsible for countywide transportation planning, programming transportation funds, managing and providing transportation programs and services, delivering transportation projects, and setting transportation priorities; and

WHEREAS, State Transportation Improvement Program (STIP) funds in the amount of \$9.36 million, and Surface Transportation Program (STP) funds in the amount of \$1.41 million, have been programmed and allocated to this project through the STA for construction of Phase 1B of Jepson Parkway; and

WHEREAS, the total project cost for the Phase 1B portion of Jepson Parkway is \$19.11 million; and

WHEREAS, Phase 1C is a part of the Agreement; however the exact scope and schedule will be defined at a later date; and

WHEREAS, the City will utilize Development Impact Fees (DIF), developer contributions, and Regional Traffic Impact Fees (RTIF) to contribute \$8.37 million; and

WHEREAS, the City will establish a Benefit District requiring new development along the Phase 1B and 1C segments to pay their fair share toward construction of the project; and

WHEREAS, the Agreement clearly defines the roles and responsibilities, project schedule and terms to which each party to the Funding Agreement shall be bound.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Vacaville hereby authorizes the City Manager to execute the Funding Agreement among the STA and City of Vacaville for the design and construction of the Phase 1B and 1C Jepson Parkway project.

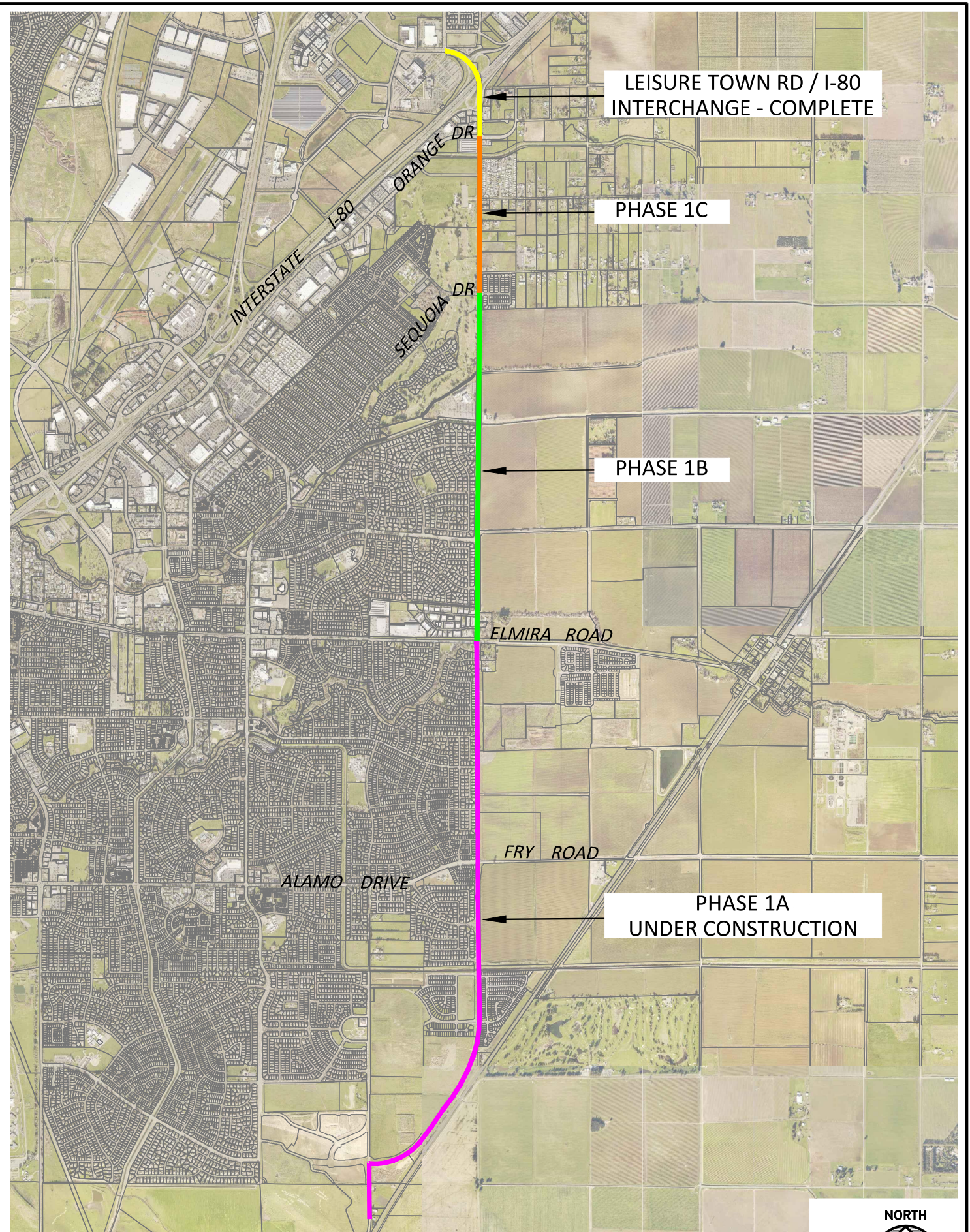
