





Big Picture: Vacaville Updates to the General Plan

The City is currently updating three key elements to its citywide General Plan document. This meeting is about the Environmental Justice Element update.





What is the General Plan?

- Main policy and planning document guiding future conservation, enhancement, and development in the city.
- Represents community values, ideals, and aspirations to govern a shared environment through 2035.
- Addresses all aspects of development including land use, transportation, housing, economic development, public facilities and infrastructure, and open spaces, among other topics.


Why this Update is Happening: SB 1000

Senate Bill 1000 is a State law known as the "Planning for Healthy" **Communities Act" and requires Cities to:**

- Incorporate policies and actions into the General Plan to alleviate, improve, and address community health concerns
- Identify "disadvantaged communities" (DACs), which are neighborhoods that are disproportionately impacted by environmental pollution
- Identify and assess specific community health conditions and challenges in these communities

What is "Environmental Justice"?

- SB 1000 uses the term "environmental justice."
- California law defines environmental justice as the "the fair treatment of people of all races, cultures, and incomes with respect to the development, adoption, implementation, and enforcement of environmental laws, regulations, and policies"
- **Environmental justice is about community** health and helping everyone live in neighborhoods that are safe and healthy



Community Health Topics Under SB 1000

- Pollution exposure and air quality
- Public facilities
- Food access
- Safe and sanitary homes
- Physical activity
- Community engagement in public decision-making
- Prioritization of improvements and programs in communities experiencing health impacts



City's Role in Implementing SB 1000 and Community Health


SB 1000 Topic	Examples of City Role
Pollution exposure and air quality	Land use planning to prevent incompatible uses near each other Water quality Transportation and traffic management
Public facilities	Police Stations Fire Stations Water treatment and distribution Sewer collection and treatment
Food access	Land use planning to incentivize grocery store locations Facilitating Farmers Markets
Unsafe or unsanitary homes	Housing assistance Code Enforcement Landlord and tenant resources
Physical activity	Parks and recreation facilities Sidewalks bike paths, and trails Landscaping and lighting



Identifying Community Health Issues

Disadvantaged Communities Mapping: CalEnviroScreen

- One common source: CalEnviroScreen 4.0
- Measures 21 indicators of pollution burden and population characteristics at a Census Tract level
- Calculates individual and cumulative scores
- Compares percentage of impact to all Census tracts in California



CalEnviroScreen Indicators


Pollution Burden Indicators

- » Ozone concentrations in air
- » PM2.5 concentrations in air
- » Diesel particulate matter emissions
- » Drinking water contaminants
- » Children's lead risk from housing
- » Use of certain high-hazard, high-volatility pesticides
- » Toxic releases from facilities
- » Traffic Impacts
- » Toxic cleanup sites
- » Groundwater threats from leaking underground storage sites and cleanups
- » Hazardous waste facilities and generators
- » Impaired water bodies
- » Solid waste sites and facilities

Population Characteristics Indicators

- » Asthma emergency department visits
- » Cardiovascular disease (emergency department visits for heart attacks)
- » Low birth-weight infants
- » Educational attainment
- » Housing-burdened low-income households
- » Linguistic isolation
- » Poverty
- » Unemployment


CalEnviroScreen 4.0 Cumulative Results for Vacaville

Stakeholder Workshop (this workshop)

Present existing conditions

Prepare Draft Environmental Justice goals, policies, actions

Community **Engagement** Round 2

Share and discuss goals, policies, and actions with community

Prepare Environmental Justice Element

Present to decision-makers



Project Schedule

- Summer 2022: Community workshop (this workshop) and present to City **Council meeting**
- Summer–Winter 2022: City and Consultant team prepare environmental justice goals, policies, and actions
- Winter 2022: Community workshops to share environmental justice goals, policies, and actions; prepare Draft Environmental Justice Element
- Early 2023: Present Draft Element to Planning Commission and City Council
- Spring 2023: Final Environmental Justice Element and Adoption Hearings
