| July 31, 2024                           | <b>FPPC Form 460 Semi-Annual Statement Due</b><br>Deadline for financial disclosure report covering 1/1/24- 6/30/24  |
| August 7, 2024 –<br>November 5, 2024    | <b>FPPC Form 497 24-hour Contribution Report</b><br>Sums of \$1,000 or more to/from a single source must be reported within 24-hours.  |
| August 9, 2024                          | <b>EC § 10220 Nomination Period Closes</b><br>Deadline to file all required nomination papers.   |
| August 10, 2024 –<br>August 14, 2024    | <b>EC § 10225 Nomination Extended Period</b><br>If the incumbent fails to file a Declaration of Candidacy by the deadline for their office, there will be a 5-calendar-day extension during which any candidate, other than the incumbent, may file for said office. |
| August 15, 2024                         | <b>EC § 13111 Randomized Alphabet Drawing</b><br>The Secretary of State will conduct a drawing of letters of the alphabet to determine the order in which candidates appear on the ballot.   |
| September 9, 2024 –<br>October 22, 2024 | <b>EC § 10229 Filing Period</b><br>Candidate Nomination Papers for Write-In Candidates.  |
| September 26, 2024                      | <b>FPPC Form 460 1st Pre-Election Statement Due</b><br>Deadline to file financial disclosure report. (7/1/24- 9/21/24)   |

| November 5, 2024  | <b>EC § 1000 ELECTION DAY</b><br>Vote Centers open from 7 a.m. to 8 p.m. for dropping off ballots or voting in person.<br>Ballots must be postmarked by this date. |
| December 5, 2024  | <b>EC § 15372 Official Canvass of Votes</b><br>Last Day for Registrar of Voters to certify election results.   |
| December 10, 2024 | <b>EC §§ 9217, 10262, 10263</b><br>Council to certify election results.  |
| January 31, 2025  | <b>FPPC Form 460 Semi-Annual Statement Due</b><br>Deadline for financial disclosure report. (10/20/24- 12/31/24)   |
