CITY OF VACAVILLE COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM YEAR 2024-2025 ANNUAL ACTION PLAN

Community Development Block Grant (CDBG) funding is awarded annually to the City of Vacaville by the U.S. Department of Housing and Urban Development (HUD) to improve the housing and neighborhood conditions in target areas, with its principal goal being to benefit low- and moderate-income persons.

The City is preparing its Program Year 2024-2025 Annual Action Plan (AAP), which authorizes CDBG program activities for the period of July 1, 2024 and ending June 30, 2025. The AAP describes activities to be undertaken, summarizes geographic distribution of these activities, and describes actions that support housing and related community development activities in the community. This program year, proposed activities include, but are not limited to: Public Service funding for Vacaville Neighborhood Boys and Girls Club and Leaven Kids, Planning and Administration, and a capital improvement project. This draft AAP includes the use of the annual allocation of \$532,369.

The draft AAP will be available for public review and comment for 30 days from May 26, 2024 through June 25, 2024 on the City of Vacaville website at <https://www.ci.vacaville.ca.us/government/housing-and-community-services/community-development-block-grant> or a copy can be requested by contacting Theresa Cristobal at the Housing and Community Services Department at (707) 449-5606 or email at Theresa.Cristobal@cityofvacaville.com.

On June 25, 2024, a public meeting will be held by the City Council at 6:00 p.m. to discuss and receive comments on the draft AAP prior to submission to HUD. All persons interested are invited to be present and submit statements either orally or in writing, prior to or during said meeting or anytime during the public comment period. Comments will be accepted through June 25, 2024. The City will consider all comments in finalizing this document before submitting to HUD.
