AMENDMENT TO THE CITY OF VACAVILLE HOUSING AND COMMUNITY SERVICES COMMUNITY DEVELOPMENT BLOCK GRANT CITIZEN PARTICIPATION PLAN

The Citizen Participation Plan (CPP) is a U.S. Department of Housing and Urban Development (HUD) mandated plan for all communities that receive Community Development Block Grant (CDBG) and Section 108 Loan Guarantee program (Section 108) funding. The CPP details the outreach efforts of the City of Vacaville in encouraging the community to participate in the planning process for projects and activities in the community.

The City of Vacaville hereby notifies the general public of its plan to submit an amendment to the CPP to HUD. The CPP identifies strategies to obtain participation from those persons directly affected by CDBG or the Section 108 program and their activities.

The Housing and Community Services Department does not discriminate on the basis of race, color, sex, gender identity, religion, familial status, age, disability, national origin, sexual orientation, marital status, ancestry, source of income, and arbitrary discrimination. It is the Housing Authority's policy to provide reasonable accommodation to persons with disabilities so that they may fully access and utilize the housing programs and related services. The amended CPP will be available for public review and comment for 30 days from September 22, 2024, through October 22, 2024. The amended CPP can be reviewed at the City of Vacaville website at www.cityofvacaville.gov/government/housing-and-community-services/community-development-block-grant or a copy can be requested by contacting Holly Babich at the Housing and Community Services Department at 707-449-5694, or email at Holly.Babich@cityofvacaville.com.

On October 22, 2024, a public meeting will be held by the City Council at 6:00 p.m. to discuss and receive comments on the amended CPP prior to submission to HUD. All interested persons are invited to participate and submit statements either orally or in writing, prior to or during said meeting or anytime during the public comment period. Comments will be accepted through October 22, 2024. The city will consider all comments in finalizing these documents before submitting to HUD.
